Dear Sheriff Mullen:

First, I would like to say how grateful I am for all the Sheriff's in the United States of America that are the highest lawful authority in every County and honor their oath to the Constitution.

The reason for my letter is last week I called your office and was informed to write a letter to you regarding the ENCLOSED **Color of Law Violation Warning** letters for **Denial of Rights Under Color of Law** that I served on the Defendant/Appellees and that are part of court filings by me.

I lived in Butler Pennsylvania for approximately 42 years and it is during that time the crime was committed against me by Appellee AK Steel et al (now Cleveland-Cliffs). I moved to Jacksonville Florida around 2004.

To provide some basic insight Appellees Bender, Dubow and Nichols are the judges on the Superior Court of Pennsylvania that filed the UNCONSTITUTIONAL Non-Precedential Decision on June 25, 2020 and Appellee Seletyn was the Prothonotary that unlawfully filed the Non-Precedential Decision when he knew it was an UNCONSTITUTIONAL Decision.
