Common law Claim of trespass – Writ of mandate - Notice to judge
michael yeager - Court Order
dated 3-7-24

I am joe myers, one of the people of the United States, provides this notice of a **common law court of record claim of 19 Counts of trespass dated 12-31-23** is against the following, **acting as defendants**: timothy f. mccune, joseph h. chivers, john/jack w. murtagh jr., graydon brewer, carl v. nanni, jack lewis, jim gallagher, greg loverick, edward tassey, Cleveland-Cliffs (formerly AK Steel, formerly Armco steel – includes all men and women acting as executives, management and board of directors) et al, lourenco goncalves, UAW - United Auto Workers (formerly Butler Armco Independent Union) et al, shawn fain, angelo papa, william cunningham, michael lettrich, maria millie jones, dennis roman, nicholas j. koch, adam hobaugh, john t. bender, alice beck dubow, carolyn h. nichols, joseph d. seletyn, bobbi jo wagner, richard a. goldinger and david r. workman.

For the same reasons listed in the **Common law Claim of trespass dated 12-31-23** filed by myers there are no capitalization of names so as not to diminish the natural rights of myers or any man or woman, **acting as defendants**.

Action at Law

1. The organic law is the Constitution for government and is altogether written to protect the natural rights of the sovereigns (We the People of the United States) the creators of the Constitution FOR the United States of America. There can be no written law that usurps the LIFE, LIBERTY or PROPERTY of any sovereign.
2. The Constitution for the Commonwealth of Pennsylvania clearly states in **Article 1 Declaration of Rights Section 2 Political Powers** that "**All power is inherent in the people**" which means that all laws must be Constitutional to protect LIFE, LIBERTY and PROPERTY of the sovereign. Pennsylvania is subject to the Constitution FOR the United States of America and federal Constitutional laws as stated in Pennsylvania Constitution laws.

3. In lawful court filing **Common law Claim of trespass** dated 12-31-23 which has **19 counts of trespass** filed by myers provides the Constitutional laws starting on **page 57** that protect myers LIFE, LIBERTY and PROPERTY and the ability for myers to do so before a common law court of record trial by jury of sovereigns.

4. This lawful court filing is a **Notice** to judge michael yeager, who is president judge in Butler County, that myers has established the law and jurisdiction of a common law court of record in myers lawful court filing **Common law Claim of trespass – notice of court of record and order - dated 2-28-24** which prohibits any equity actions such as preliminary objections, discovery, or any further usurpations of myers natural rights as those usurpations are unlawful in a common law court of record.

5. This lawful court filing is also a **Writ of mandate** to require the officers and employees of Butler County to perform their duty to immediately schedule a trial by jury. The law under **U.S.C. Title 28 Section 1361** provides original jurisdiction to the district courts to compel officers and employees to do their duty owed to myers validating myers as the sovereign. If Butler County officers and employees do not schedule the trial by jury immediately myers intends to file with the district court. See **U.S.C. Title 28 Section 1361** below:

"The district courts shall have original jurisdiction of any action in the nature of mandamus to compel an officer or employee of the United States or any agency thereof to perform a duty owed to the plaintiff."

6. On 3-5-24 david r. workman had the unlawful oral arguments ignoring myers warning. At that meeting myers made the following statement on the record via zoom call:

"I would like to make a statement so please let me finish my statement in its entirety."

I object to this unlawful meeting for the following reasons:

I object to the jurisdiction of this court and the attempt to have this unlawful meeting as this is not a common law court of record that I have already established which means since I filed a lawful common law court of record claim there can be no other hearings but a trial by jury where all parties will be judged by a common law trial by jury of sovereigns.

Mr. workman I have added you now, acting as a defendant, so you must recuse yourself unless you are putting an end to this meeting and scheduling the jury selection date and the trial by jury of sovereigns date.

This has all been explained in my lawful filing of Common law Claim of trespass - notice of court of record and order - dated February 28th, 2024.

For this reason, anything stated in this meeting or any further action is unlawful.

Any further action is a trespass of my natural rights that allows me to protect my life, liberty and property therefore this meeting is concluded."

7. Since myers has lawfully added the man: david r. workman, NOW acting as a defendant, in **Common law Claim of trespass - adding the man - david r. workman, acting as a defendant, as part of the conspiracy, obstruction of justice and contempt of court - dated 2-19-24** workman no longer can take any actions and since judge yeager chose to recuse himself then he must replace workman with another judge and myers requires an active judge to be the magistrate and not another retired judge like workman and cunningham as they do not know the law.

8. As the president judge of the Butler County courts michael yeager is required to make sure the laws are followed in Butler County court by judges and myers has repeatedly required a jury selection date and a trial by jury date under common law established in the 7th Amendment and supported by Pennsylvania law that is required to commence immediately by the new judge.

9. The officers and employees of Butler County must notify and inform all the men and women, acting as defendants, of the **signed Order by myers** of the jury selection date and trial by jury date and no further actions by those acting as defendants are permitted as they will be able to state their case before the jury just as myers.

Since myers established a common law court of record, myers has signed the attached order that must be followed. The men and women, *receiving compensation from tax dollars*, must assign the ***jury selection*** date and ***trial by jury of sovereign's*** date.
