Mr. Goldinger,

Per my email yesterday I made you aware that I called the U.S. Attorney of the Western District of Pennsylvania per your email to contact their office. Today they called me back and informed me that they will pursue prosecutions once they receive a report from the FBI of the criminal activity against me BUT they also stated you have the duty to investigate and prosecute the conspiracy and criminal activity against me as the Constitutional GUARANTEES me RIGHTS and specifically the RIGHT to a JURY TRIAL and there are State laws that protect me and you are sworn to uphold the Constitution and prosecute ALL involved.

In addition to all the evidence I have provided you and communications I have had with you Appellee AK Steel (now Cleveland-Cliffs) is still committing a crime by directing their employees to operate vehicles in violation of their own written directives that is NOW PUBLIC POLICY LAW which you must investigate along with the crimes committed against me and prosecute ALL involved.
