Senator Rubio, Congressman Rutherford, Governor DeSantis, Representative Kelly,

This email is to once again request a **Congressional Hearing** regarding the continued conspiracy of my Constitutional Rights and as each one of you are CIVIL SERVANTS to We The People and your main responsibility is to follow the Constitution of the United States of America and protect the INDIVIDUAL RIGHTS of every Citizen.

My case started on July 9, 1998 when Appellee AK Steel now Cleveland Cliffs committed a criminal act when I was illegally ordered to not secure a pinion gear on a Stake Truck that rolled over with me inside when the load shifted as I was driving with the potential to injure or kill me. After the Stake Truck rolled over with me inside I was shown pictures of the incident happening to another co-worker, Dan Redick, where the same pinion gear shifted and raised the rear axle of the Stake Truck off the ground but did not roll the truck over. I was never informed of the incident of Dan Redick which is a criminal act on the part of Appellee AK Steel/Cleveland Cliffs and their agents.

After this incident I called the **Pennsylvania Attorney General's Office** and spoke to **David Deveries** and informed him of the aforementioned issue and that myself and co-workers we being illegally ordered to operate defective heavy equipment and operate overloaded and unsecured tractor trailers against Appellee AK Steel/Cleveland Cliffs own written directives and Devries informed me that in the event someone was hurt or killed while violating Appellee AK Steel/Cleveland Cliffs own written directives was against Public Policy Law that we as employees could be held civilly and criminally liable and quite possibly serve a jail term.

After 17 years of service I was terminated in 2001 by Appellee AK Steel/Cleveland Cliffs when I was again illegally directed to not secure a load and operate a tractor trailer not rated to haul the excessive weight of the trailer and I informed my supervisor, Appellee Tassej I would not be able to legally do that and referenced my conversation with David Devries but I informed Appellee Tassej that I would perform the job as long as I could follow the law of the rating of the tractor and trailer and if I could have chains on the trailer to secure the load. Appellee Tassej had me then escorted out of the plant.

I then contacted Appellee McCune who was the District Attorney at the time to investigate the criminal activity to which he stated to me in a phone call unless there was a fatality he was not coming into Appellee AK Steel/Cleveland Cliffs plant to investigate.

Appellee AK Steel paid the salaries and overtime of the officers (that they did not have to work for) of the illegal Appellee UAW union as well as provided an on plant union hall and the Appellee UAW co-conspired with Appellee AK Steel/Cleveland Cliffs against my Constitutional Rights.

Appellees Chivers and Papa were supposed to protect me in court as legal counsel and had all the evidence I provided in my recent **Concise Statement** court filing dated 2-4-20 filed that was part of my evidence to the Superior Court of Pennsylvania.

In 2003 I compiled the evidence in a 300 plus page document and sent the documents via Certified U.S. Mail to then U.S. Attorney General Ashcroft as well as the list of the following to name a few of which ALL violated their oath to the Constitution of the United States of America and co-conspired against my Constitutional Rights by the very fact of do NOTHING:

- George W. Bush - then President

- Tom Ridge - the Homeland Security
- Ed Rendell - then PA Governor
- Mike Fisher - then PA Attorney General
- Alen Specter - then PA U.S. Senator
- Rick Santorum - then PA U.S. Senator
- Phil English - then PA U.S. House of Representative
- Mary Jo White - then PA State Senate
- Guy A. Travaglio - PA State House of Representative

After repeated requests to meet with George W. Bush regarding the corruption I received a letter from his Assistant Melissa Bennett dated 2-5-05 stating Bush did not have time to meet with me. What a SHOCK another CIVIL SERVANT conspiring against my Constitutional Rights!!!

After sending a letter to then Senator Martinez he sent me a letter dated 10-3-06 that he would contact the appropriate agencies but I never heard ANYTHING! Again what a SHOCK another CIVIL SERVANT conspiring against my Constitutional Rights!!!

After sending a letter to then Senator Nelson he sent me a letter dated 6-4-07 stating he was pursuing my case but I never heard ANYTHING! Again what a SHOCK another CIVIL SERVANT conspiring against my Constitutional Rights!!!

After learning what the Constitution of the United States of America really says instead of the nonsense I learned in the UNCONSTITUTIONAL government indoctrination schools I filed a new Complaint representing myself on 5-29-19 for violation of my Constitutional Rights!

When the Commonwealth judge co-conspired and violated my Constitutional Rights I filed the **Violation Warning** letter for **Denial of Rights Under Color of Law** against the judge and all defendants and their legal counsel.

I then appealed to the Superior Court of Pennsylvania and the judges recently filed the **Unconstitutional Non-Precedential Decision dated 6-25-20** that is also attached to this email.

I then filed **Appellant's Demur To Non-Precedential Decision and WARNING to the COURT 7-2-20** which is attached to this email and WARNED the Court and judges for conspiring against my Constitutional Rights and the Court must either rule that I receive my damages requested or schedule a JURY TRIAL and if not they were served with the appended **Violation Warning** letter for **Denial of Rights Under Color of Law** in the court filing and they would be added to the court filing as Appellees I will make to the Supreme Court of Pennsylvania.

My challenge to **Senator Rubio, Congressman Rutherford, Representative Kelly** and **Governor DeSantis** is that if you do not do your part as CIVIL SERVANTS to WE THE PEOPLE to have a **Congressional Hearing** on my case that affects the INDIVIDUAL RIGHTS of every Citizen I will be filing a **Violation Warning** letter for **Denial of Rights Under Color of Law** and serving each one of you.

I expect to hear back from EVERYONE of you because you serve WE THE PEOPLE that are the SOVEREIGNS not any of you while in your government positions!
