

ORDER

On this 9th day of April 2024, it is hereby Ordered that joe myers, one of the people of the United Sates, is awarded the following compensation:

- **\$100 million** for compensatory and punitive damages from Cleveland-Cliffs et al, **the entity acting as a defendant**, controlled by lorencio goncalves, **acting as a defendant**, which **Exhibit AA** states gonclaves is the *Chairman, President and Chief Executive Officer* of Cleveland-Cliffs et al.

- **\$100 million** for compensatory and punitive damages of from UAW et al, **the entity acting as a defendant**, controlled by shawn fain, **acting as a defendant**, the *president* for UAW et al.

- **\$10 million** for compensatory and punitive damages from all men and woman, **acting as defendants**, for their involvement in the conspiracy against myers natural rights.
