John W. (Jack) Murtagh, Jr. is a native of Brooklyn, NY and a graduate of Regis High School in Manhattan. He attended Saint Joseph's College (now University) in Philadelphia, earning an A.B. degree, magna cum laude, in Political Science, with a minor in Philosophy. After graduating from the University of Pennsylvania School of Law with a J.D. degree, cum laude, in 1972, he clerked for the Honorable Donald W. VanArtsdalen, Judge of the United States District Court for the Eastern District of Pennsylvania. He married Sheila Ann Horsman of Beaver County in 1972. Jack was appointed as a Special United States Trial Attorney with the United States Department of Justice, Criminal Division, Organized Crime and Racketeering Section in 1973, and assigned to the Pittsburgh Field Strike Force. In that capacity, he conducted grand jury investigations in Pennsylvania, West Virginia, Maryland and New Jersey, with a concentration in arson mail fraud and extortion cases. Notified of an impending transfer to another Strike Force office he resigned in order to remain in Pittsburgh, where he and Sheila chose to raise their two children, Kerin and John. While John is currently living in West View, Kerin and her family - husband Anthony, children Ryan and Gabriela - have relocated to Charlotte, NC. He practiced labor and employment law with Stan Greenfield from 1976 through 1987 when he opened an office in Wexford where he continues to represent individuals facing employment and discrimination issues. The practice today involves matters running the gamut from employment contracts, non-compete and confidentiality clauses, age, disability, race, sex, national origin and religious discrimination, unemployment compensation, grievance arbitration and commercial/business litigation. A member of the Pennsylvania and Allegheny County Bar Associations, Jack is a frequent presenter on employment law and litigation practice for the Pennsylvania Bar Institute and a contributor to various PBI publications. He also serves as a mediator and early neutral evaluator for the United States District Court for the Western District of Pennsylvania. For over 25 years, Jack has served as the Solicitor, and later Board Member, of the Northland Public Library Authority, the second largest library in Allegheny County. He has also sat as Member and Treasurer for the McCandless Industrial Development Authority, member and Past Grand Knight of Our Lady of Olives Council 3907, Knights of Columbus in Wexford, and is an avid member of the Western Pennsylvania Conservancy. Sheila and Jack have made their home in Ingomar, Town of McCandless, for 40 years, the base from which they undertake frequent trail cycling rides. When not on the trail, Jack is usually found in his vegetable gardens, one at home and one at the office.

He has litigated jury and non-jury trials in both state and federal court and has testified as an expert witness in bankruptcy-related litigation. Alan has represented the United States Departments of the Interior, Commerce, Health and Human Services, as well as federal agencies such as the Internal Revenue Service and the Small Business Administration. In private practice, Alan was a member of the legal team which obtained a \$1.7 million dollar judgment against Co-Executors of a descendant's estate for fraud and breach of duty. As a Bankruptcy Trustee, Alan managed a large underground coal mine in southwestern Pennsylvania while negotiations for acquisition were completed. Alan is admitted to practice in all Pennsylvania and Federal Courts, including the Third Circuit Court of Appeals, the United States District Court, United States Bankruptcy Court, and the United States Tax Court. Mr. Cech received his J.D. from the University Of Pittsburgh School Of Law in 1980. He completed the United States Justice Department's Program in Trial Advocacy in 1987. Alan has served as President of community and school arts groups, as a Board Member of the McCandless Industrial Development Authority, and for 10 years served as the Solicitor for the Northland Public Library Authority.
