After my illegal firing I contacted then Butler County District Attorney Tim McCune who stated to me he had no opinion on employment issues and refused to investigate and ultimately Keith Eckenrode was killed at the plant. I can supply his letter to as evidence.

Papa then filed in Federal Court without my consent and I now know it was to have another court try to railroad me.
