Governor DeSantis,

Per my conversation today with Madison Nykamp from your office and she mentioned to me that there was no record of me sending emails to you so please find attached the email replies that I received from your office after I sent each email.

Per this email to me from Madison she provided your email address so I am emailing you as well as Senator Rubio and Congressman Rutherford's office so someone will have a record of this email.

Per my conversation today with Madison I explained that I have been the victim of corruption at the local, state and federal level and the abuse of power at the office of then President George W. Bush. On my website at 1776ToTyranny.com on the **Timeline of CORRUPTION** page anyone can view all the evidence and record of corruption I have dealt with since 1998. After requesting a meeting with Bush numerous times I received the attached letter **Government Exhibit 7 - Letter from President Bush dated 2-2-05** from the White House after I had sent an approximate 300 page document to then U.S. Attorney General Ashcroft in 2003 as well as the FBI and numerous Congressman and Senators detailing the corruption and criminal activity perpetrated against my family and I.

Senator Rubio started a Congressional Inquiry after I sent him a letter last year stating I refiled my case representing myself. I have recently appealed to the Supreme Court of Pennsylvania because of the fraud and corruption of the Commonwealth Court judge and the 3 justices and prothonotary of the Superior Court of Pennsylvania.

Senator Rubio received the attached **DOJ-FBI Response to Senator Rubio dated 2-20-20** from DC regarding my case and for me to contact the Jacksonville FBI. I made several calls to the Jacksonville FBI office and was asked in May 2020 to send more information which I did by sending the attached **FBI Letter dated 5-8-20** to the Jacksonville FBI office along with other evidence.

This morning I called the Jacksonville FBI to ask to speak with the agent in charge for an update. I was connected with Steve Daugherty and he asked for my name and phone number and the details of my case and stated he would find out who the agent in charge is and have him/her call me.

I followed up with Chris Miller from Congressman Rutherford's office a couple times in the past week to ask if the Congressman had followed up with the FBI regarding my case but Chris will not return my calls.

Governor DeSantis I am asking you to follow up with the Jacksonville FBI to move my case along for the investigation and prosecution of all involved who have lied, committed fraud and committed crimes to impede justice for my family and I.

I would hope that you have the respect for your sworn oath to uphold the Constitution to make sure you use the full weight of your office as Governor to bring an end to this corruption at the local, state and federal level against my family and I.
