Senator Rubio, Congressman Rutherford and Governor DeSantis,

This correspondence is to provide a further update regarding the corruption perpetrated against me at the local, state and federal level.

I received the email from Senator Rubio with the attached letter *time/date stamped 2-12-20* from **Calvin A. Shivers, Deputy Assistant Director of the Criminal Investigative Division** to Senator Rubio.

I immediately called the Jacksonville FBI Field Office to provide more information and was transferred to a few people and was ultimately told that if the FBI needed more information they would contact me. I did not hear anything so approximately a month later I made a follow up call and was given the same response. Yesterday I called the Jacksonville FBI Field Office again and was again given the same response so I asked if I could send my **Appellant's Brief** to the Jacksonville FBI Field Office and I was informed to mail my correspondence to the **Jacksonville FBI Field Office Criminal and Civil Divisions** so I did via U.S. Mail Certified Return Receipt on 5-8-20.

Additionally I have mailed my **Appellant's Brief U.S. Mail Certified Return Receipt** to **Governor DeSantis** and **Congressman Jordan** of the **House Oversight and Government Reform Committee**. I requested Congressman Jordan and Governor DeSantis to use their authority for a Congressional Hearing to investigate and prosecute those that violated and usurped my Constitutional Rights and conspired against my Rights **USC Title 18 Section 241 Conspiracy Against Rights**. The attached letters I sent and the **Appellant's Brief** with the **Concise Statement** appended is attached as well.

In light of my experience and the recent FBI corruption against General Flynn my faith is waning in the FBI so I am demanding as a Citizen of the United States of America that you folks will honor your sworn oath to uphold the Constitution and protect my RIGHTS by scheduling a Congressional Hearing immediately!

I would remind all elected and appointed officials of the words of **Justice Brandeis** as he eloquently affirmed his condemnation of abuses practiced by Government officials in the case of **Olmstead vs. U.S. 277 US 438, 48 S.Ct. 564, 575; 72 L ED 944 (1928)** he declared:

*"Decency, security, and liberty alike demand that Government officials shall be subjected to the same rules of conduct that are commands to the Citizen. In a Government of laws, existence of the Government will be imperiled if it fails to observe the law scrupulously. Our Government is the potent, the omnipresent teacher.*

*For good or for ill, it teaches the whole people by its example. Crime is contagious. If the Government becomes a law-breaker, it breeds contempt for law; it invites every man to become a law unto himself. It invites anarchy. To declare that, in the administration of the law, the end justifies the means would bring a terrible retribution. Against that pernicious doctrine, this Court should resolutely set its face."*

My family and I have gone over 20 years dealing with this corruption that federal government officials and agencies have been complicit in continuing to allow to go on so I want a response from everyone in my demand of a **Congressional Hearing** on my families and my behalf to investigate and prosecute ALL the current and past elected and appointed officials at the local, state and federal level that are or have been complicit in the conspiracy against my family and I.
